Rainbows End Cabins at Mt. Rainier welcomes you! We are your premiere destination “vacation-home-away-from-home” at Mt. Rainier! We have done everything possible to make your vacation a memorable occasion. We have a few basic rules that we sincerely hope that you will take into consideration as part of your rental agreement with our company. We do welcome “feedback” about your stay, so please leave us a note, or simply email us!

1. As you will notice, Rainbow’s End Cabins at Mt. Rainier, takes great pride in the care of our cabins. We provide clean linens, kitchen ware, paper products, and maintenance of the hot tub and premises. We expect you to leave your cabin in a neat and tidy condition. We will dispose of trash and thoroughly clean after each rental. If we find we have extra work washing pots, pans, dishes, etc. we will add an additional \$50.00 cleaning fee to your bill. Guests are expected to wash, dry, and put away dishes used.
2. Rainbows End Cabins has the right to evict guests from our cabin properties if rules are broken. The guest will forfeit any payments and deposits as a result of said eviction.
3. Cancellations made 30 days or greater of rental contract dates are subject to a 50% cancellation fee. If the cancellation is made less than 30 days of rental contract date, there will be no refund of fees.
4. Rainbows End Cabins are NON-SMOKING establishments. If there is evidence, smell of smoking, there is an automatic \$200.00 fee to rid the signs/scent of smoke from the building or property.
5. Rainbows End Cabins charges a \$35.00 mailing fee plus shipping costs to return items left behind by the occupants. We will hold any left items and contact you to get your permission and payment before returning said items.
6. Rainbows End Cabins is not responsible for accidents or injuries to renters, pets, or their guests. Renters assume ALL LIABILITIES for the well-being of themselves, their pet(s), and visiting guests, and will not hold Rainbows End Cabins at Mt. Rainier or property owners liable.
7. Visiting guests are not allowed to spend the night. A \$20.00 per person per night fee will be charged if this occurs. Same rate applies for approved additional guests.
8. Rainbows End Cabins is not responsible for lost or stolen property.
9. Rainbows End Cabins allows up to 2 dogs at any pet friendly property for a \$50.00 fee. Add’tl pets must be authorized. All best friends (dog/pets) accompanying you must be supervised at all times and are not allowed on the furnishings.
10. Rainbows End Cabins requests that you please notify us through your rental contact if you have any guests under the age of 18. The party responsible for initiating the rental contract assumes full responsibility for all guests of their contract regardless of their guests age.
11. By receipt of this policy statement confirming the rental contract that you initiated with Rainbows End Cabins at Mt. Rainier, you are authorizing Rainbows End Cabins at Mt. Rainier to charge any/all applicable lodging fees, adventure package add-ons fees if selected, taxes, and the required \$200.00 minimum security hold to the credit card that you indicated in the rental agreement that you initiated with Rainbows End Cabins at Mt. Rainier.
